### ETHICS QUESTIONNAIRE<sup>1</sup>

The following questions relate to the last **5 or 10 years** (hereinafter “5-year-period” or “10-year-period”). If the question relates to ethical violations as per art. 11 para. (2) lit. a) of Law No. 252/2023 related to rules of ethics and professional conduct, the applicable period is 5 years. If the question relates to ethical violations as per art. 11 para. (2) lit. a) of Law No. 252/2023 related to arbitrary conduct or acts, the applicable period is 10 years. If the question relates to ethical violations as per art. 11 para. (2) lit. b) of Law No. 252/2023, the applicable period is 10 years.

The **period** is calculated as follows: The beginning of the period is the first day of the month 5 or 10 years ago, in which the Commission sent to you this questionnaire with a request to fill it out. The period ends the last day of the month 5 or 10 years ago, preceding the month in which the Commission sent to you the questionnaire.

*For example, if the Commission sent you this questionnaire on 15 March 2024, the questionnaire covers the 10-year-period from 1 March 2014 until 29 February 2024.*

If any of the **relevant events** in this questionnaire fall (partially) into the period, you need to answer “Yes”.

*For example, you have been party as a claimant to a civil case from 1 July 2009 until 15 March 2015. If the period starts on 1 March 2015, you need to check “Yes”.*

A **continuous** ethical violation falls into the 10-year-period, if it was still ongoing when the period started.

*For example, if you were investigated for an incompatibility that started in January 2013 and ended in April 2015, you need to report the incompatibility in this questionnaire.*

**Alleged** violations count in terms of the period as if they had taken place.

*For example, if you were subject of an investigation for an alleged incompatibility that – if it had taken place – started in January 2013 and ended in April 2015, you need to report this in this questionnaire, even if the competent authority found the allegations to be without base.*

Any **fact** related to a potential violation falling into the respective period needs to be reported, even if the fact occurred before the respective period.

All facts are relevant, whether **domestic** or **abroad**.

*“Personal capacity”*: If you are sued by someone to whom you sold your car, or if you are witness in a trial of your wife against her employer, you do so in your personal capacity. But, if you prosecuted a defendant, you are not acting in your personal (but official) capacity; same, if you are called as a witness on what an investigator told you during pretrial investigations.

If the final decision on the outcomes of the instituted proceedings or case filed is publicly available, please indicate the issuing authority, the number of the case/decision, the name and the decision date.
